TERMS AND CONDITIONS

(1) JOINT AND SEVERAL AGREEMENT

If the premises are rented to more than one lessee, all are jointly and severally responsible for the payment of rent and all covenants and terms of this agreement.

Lessee shall reimburse Lessor for the total cost of any repairs for which he/she is responsible for hereunder.

(4) RELEASE OF LIABILITY

Lessee hereby releases Lessor, including Lessor's employees, agents, invitees and other guests from any and all liability arising from loss, damage or injury caused by Lessee or Lessee's family members, guests, or invitees. Lessor shall not be liable for any damage or injury occurring on or about the premises to Lessee, his/her family members, guests or invitees or to any personal property whatsoever that may be on the premises, except in the case of Lessor's failure to perform, or negligent performance of, a duty imposed by law. Lessee hereby agrees to protect, indemnify and hold Lessor harmless from and against any and all loss, costs, expense, damage or liability arising out of any action or other occurrence on the premises or any part thereof, or in any common area including parking lot causing injury to any person or property whomsoever or whatsoever, no matter how caused except in the case of Lessor's failure to perform, or negligent performance of, a duty imposed by law.

(5) INDEMNIFICATION

Lessee shall indemnify Lessor against and hold it harmless from any and all liabilities, obligations, damages, penalties, claims, cost and expenses, including actual attorneys fees, paid or incurred as a result of or in connection with (i) Lessees use or occupancy of the premises, (ii) the carelessness, negligence or improper conduct of Lessee, any sub-lessee, or any of their agents, contractors, employees, customers, invitees or licensees or (iii) any breach by Lessee, any sub-lessee, or any of their agents, contractors, employees, customers, invitees or licensees, of any covenant or condition of this lease. Furthermore, Lessee shall bring or keep property on the premises solely at his or her own risk, and Lessee shall not under any circumstances be liable for any damage thereto or any destruction or theft thereof.

(6) NOTICES

All communications required hereunder shall be in writing and shall be deemed to have been given and either delivered personally or mailed first class to a party at the address set forth on the first page of this agreement.

(7) AMENDMENT

This agreement, including any exhibits, riders and the rules attached hereto, represent the entire agreement between the parties. No oral or written, prior or contemporaneous agreement shall have any force or effect, and this agreement may not be amended, altered or modified unless done so by means in a written instrument signed by both parties.
